

## OFFICIAL RULES

### DUVEL USA® 2024 DUVEL POUR & WIN SWEEPSTAKES

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. MUST BE 21 OR OLDER TO ENTER. INTERNET ACCESS REQUIRED TO ENTER.**

- 1. Eligibility.** The **DUVEL USA® 2024 DUVEL POUR & WIN SWEEPSTAKES** (the “**Sweepstakes**”) is open to legal residents of the United States who are at least twenty-one (21) years of age at the time of entry. Employees (and their immediate families) of Boulevard Brewing Company (the “**Sponsor**”) and any of their parents, subsidiaries, affiliates, suppliers, independent contractors, agencies, alcoholic beverage wholesalers and retailers, and any persons living in the same household as such employees are not eligible to participate in the Sweepstakes (cumulatively, the “**Sweepstakes Entities**”). Sweepstakes is subject to all applicable federal, state, local laws and regulations and is void where prohibited by law.
- 2. Sweepstakes Period.** The Sweepstakes begins at 12:00 a.m. Central Time (“CT”) on 5/1/2024 and ends at 11:59 p.m. CT on 10/31/2024 (the “**Sweepstakes Period**”).
- 3. How to Enter:** Visit [duvel.com/pourandwin](https://duvel.com/pourandwin) (“**Website**”) and follow the online instructions to enter for a chance to win.
- 4. Limited one (1) entry per method per person.** Duplicate entries per method for a single individual will be disqualified. All entries become the property of the Sponsor.
- 5. Prize and Odds of Winning.** One (1) Grand Prize Winner will be selected in a random drawing on about 9/2/2024 from all eligible entries received during the Sweepstakes Period. Grand Prize Winner will receive one \$2,500 Visa gift card and a private tour of Duvel Moortgat Brewery in Belgium. Approximate Retail Value (“**ARV**”) of \$2,500. The prize will be provided “as-is” and the difference between any stated value and actual value will not be awarded to winner. All costs and expenses not specifically mentioned herein are the sole responsibility of the winner. The random drawing, selection of the winner, and awarding of the prize will be conducted under the supervision of Sponsor whose decision is final and binding in all matters pertaining to this Sweepstakes. No prize substitution, transfer or assignment will be allowed, except that Sponsor and Prize Provider reserves the right to substitute a prize of comparable, equal or greater value if the prize listed is unavailable for any reason. All costs, taxes, fees, and expenses associated with a prize are the sole responsibility of the winner. Odds of winning depend on the number of eligible entries received. Other prize restrictions may apply.
- 6. Notification and Verification of Winner.** Potential winner will be notified by email, text message, U.S. mail, telephone, or private delivery service (at Sponsor’s sole discretion) and will be required to sign and return an Affidavit of Eligibility and Release of Publicity and Liability (where permitted by law) within three (3) days of notification. Sponsor will make one attempt to notify potential winner, who will have forty-eight (48) hours to respond. Winner’s age is subject to independent age verification, and if failed, will result in prize forfeiture. In the event of noncompliance, if the winner cannot be reached at the phone number, email address or address on that winner’s entry, or if the prize or prize notification is returned unclaimed or undeliverable for whatever reason beyond the control of Sponsor, that prize will be forfeited, and an alternate winner may be selected only if time permits and in Sponsor’s sole discretion. If for any reasons (including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other cause beyond the control of the Sponsor, which corrupts or affects the administration, security, fairness, integrity or proper conduct of the Sweepstakes), the Sweepstakes is not capable of being conducted as described in these official rules, Sponsor shall have the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes, or disqualify entries.

9. **General Conditions.** Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these official rules, or to be acting in disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

10. **Disputes.** Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Jackson County, Missouri.
